成立目的

a) Ordinary Members

Ordinary membership shall be open to all HKSAR Citizens and Hong Kong & Chinese Permanent Residents aged 18 and above. Ordinary Members shall have the rights to vote and be elected to hold office in the Association.

b) Corporate Members

Corporate Membership shall be open to registered companies and businesses in Hong Kong. Each Corporate Member shall nominate one representative who shall have the full rights and privileges of an Ordinary Member, including the rights to vote and hold office in the Association.
